# Stanley faced sexual harassment claim

Former Sinn Féin TD insists complaint against him was 'politically motivated'

Party inquiry repeatedly found aspects of Stanley's evidence not to be credible

An internal Sinn Féin inquiry into a complaint against Laois-Offaly TD Brian Stanley was preparing to make a finding against him of gross misconduct on grounds of sexual harassment when he resigned from the party a fortnight ago, internal party documents

Mr Stanley and the young woman who made the complaint were told that after an inquiry, which heard testimony from both sides, the party intended to make a finding that she had been telling the truth and parts of his evidence were "not credible", according to a draft report of the inquiry seen by The Irish Times.

elled to meet Mr Stanley. She had previously worked for Sinn Féin several years ago, and was seeking advice on applying for employment in the EU. At Mr Stanley's invitation they ate together at Leinster

House and had drinks at a pub. The Sinn Féin inquiry repeatedly found aspects of Mr Stanley's evidence to be not credible and ultimately said that "taking all the available evidence into consideration, that on the balance of probability that narrative as put forward by the complainant is essentially true", the draft report states.

The woman said she was upset and traumatised in the days following the incident, and communicated with Mr Stanley by is involved with others in the text message. The texts v presented as evidence to the inquiry, which it said in the draft report were "not disputed".

She sent him a request for €60,000 to compensate her for what she claimed happened on the night, text messages show.

The woman now says that her request for money was an 'unwise, idiotic, and ill-judged decision while in a state of shock and powerlessness"

# Man jailed for life over 'depraved' catfishing

A Co Armagh man whose online catfishing caused the death of a 12-year-old girl in the US has been sentenced to life with a minimum of 20 years in jail.

As he sentenced Alexander McCartney (26), from Lissummon Road in Newry, for a total of 185 charges including manslaughter, yesterday Mr Justice O'Hara said "he used social media on an industrial scale to inflict ... terrible and catastrophic damage on young girls".

rron Thomas from West Virgin-May 2018 after she was targeted on Snapchat.

Her father Ben Thomas, a US army veteran, took his life 18 months later.

Other charges admitted by McCartney included multiple Fake online profiles offences of causing a child to engage in a sex act while he pleaded guilty to 58 charges of blackmail and multiple offences of possessing indecent images of children in a period of offending from 2013 to 2019.

McCartney's spanned the globe and he used their friends and family. social media to exploit young girls aged between 10 and 16.

Primarily using Snapchat as well as Instagram and Kik, he engaged in catfishing - whereby he created fake online profiles pretending to be young teenage girls - to deceive his victims into sending sexual images of themselves.

> Outside court, Detective Chief Superintendent Eamonn Corrigan, from the Police Service of Northern Ireland, said: McCartney's offending was on an "industrial scale".

"I reflect on the judge's comments, McCartney is a dangerous, relentless, cruel paedophile," he said. "There was nothing that was going to stop him, apart from putting him in

He added: "We believe that

the number of victims is approximately 3,500. We have identified as many as we possibly could. Obviously, to charge and identify all those offences would be impractical, so a sample of cases were brought for-
