Airport fees are taking flight

Rates for airlines, rental car customers to help pay for \$1.57B modernization

Fees for Pittsburgh International Airport airlines and rental car customers are taking off next year to help pay for a \$1.57 billion terminal modernization.

The carriers will be hit with a 29.2% hike in the cost per enplanement, while travelers and others who rent cars are facing a whopping 33.3% jump in a customer facility charge, the second increase in five

In a slide presentation on the

2025 budget, the Allegheny County Airport Authority, which operates Pittsburgh International, tied the increase in the cost per enplanement to the debt service payments that will kick in next July once the new landside terminal is completed.

The cost to the airlines to board a passenger next year will jump from \$11.95 to \$15.44. The 29.2% increase comes after the airport authority reduced the cost by two

It is still lower than the \$20.50 airlines paid in 2020 during the height of the COVID-19 pandemic when passenger traffic plummeted to record lows. But it's much higher than the \$9.77 the airlines paid in 2019.

The new rate is also greater than the \$14.97 they forked over in 2011. That was the all-time high before

WASHINGTON — Speaker Mike Johnson, R-La., said Friday that he will urge the House Ethics Committee to suppress its report into former congressman Matt Gaetz, R-Fla.,

and block the Senate Judiciary Committee from viewing the investigation, an unusual intervention that could shape a divisive nomination fight.

"I'm going to strongly request the Ethics Committee not issue the report because that is not the way we do things in the House, and I think that would be a terrible precedent," Mr. Johnson told reporters midday

Pressed again on whether he would stop it from coming out publicly or from going to the Judiciary Committee for consideration of Mr. Gaetz's nomination, Mr. Johnson said, "I'm going to request that it not

be."

WASHINGTON — Republican David McCormick — the senator-elect, according to the Associated Press — is appealing Philadelphia County's decision this week to count 600-plus undated or misdated ballots as his contentious race with incumbent U.S. Sen. Bob Casey boils over

District won't close any buildings in 2025-26 as officials review suggestions

After months of uncertainty about a potential major overhaul of Pittsburgh Public Schools, the district Friday evening announced that no school closures or grade reconfigurations will take place in the 2025-26 school year.

Instead, the district will use the additional time to conduct a more comprehensive review of recom-

mendations that could close 14 schools and change grade reconfigurations at 12 others.

"It's very positive, because I felt like this was an incredibly rushed process," Nathan VanHoudnos, who has three children in the district, told the Pittsburgh Post-Gazette on Friday evening. "So I'm glad that the district is taking the additional time necessary to roll out changes like this."

The announcement came exactly a month after Massachusettsbased education consulting firm Education Resource Strategies presented final recommendations that included school closures and streamlining grade structures to follow a PreK-5 and 6-8 model
