The right finds a new way to wage war on judiciary

MKs milk Sde Teiman scandal to sow fear and legitimize soldiers' terrible acts

The notion that the end of the war with Hamas will mend the divide within Israeli society has proved fundamentally wrong. With the eruption of the military advocate general affair, coming less than two weeks after the start of the cease-fire in Gaza, regime change is back - this time on steroids.

The right-wing campaign is deliberately polarizing the debate, from the failures that enabled the October 7 massacre through the failure to vanquish Hamas as promised, to the renewed assault on the judicial system. It's an unconstrained attack, in which the declarations of Tally Gotliv and her ilk are not the exception, but the rule.

The intent is to sow fear in the hearts of the gatekeepers, protesters and opposition heads (most of the third group has long been silenced anyway), ahead of the Knesset elections to be held within a year. The noise level will be constantly high from now on. It's hard to rule out the possi-

bility that security tensions will intensify, should the political need arise.

There are added bonuses in this strategy. They'll be able to again blame the jurists for allegedly enabling the massacre (instead of the one who will never take responsibility for anything),

Bodies of slain soldiers Omer Neutra, Asaf Hamami and Oz Daniel returned to Israel

The bodies of three IDF soldiers handed over by Hamas on Sunday were identified on Monday morning as Col. Asaf Hamami, Sgt. Oz Daniel and Israeli-American Capt. Omer Neutra.

"We got Neutra, you know, from New York, from the United States. I spoke to his parents," Trump told the press on board Air Force One. "They're thrilled in one sense, but in another sense, obviously, they're not too great. But we're very happy because we've got three bodies back today.

Court extends detention of IDF's former top lawyer by three days

An Israeli court on Monday extended the detention by three days of Military Advocate General Yifat Tomer-Yerushalmi, who was arrested on Sunday night as part of the investigation into

the leak of a video showing the abuse of a Palestinian detainee by Israeli guards. During a hearing on Monday, the judge said that

the grounds for extending Tomer-Yerushalmi's detention were due to the danger she poses as well as concerns over potential interference

with judicial proceedings. The police initially requested an extension of her detention by five days.

Tomer-Yerushalmi, suspected of fraud and breach of trust, abuse of office, obstruction of justice and disclosure of official information by a public servant,

admitted to leaking the video and announced her resignation on Friday.

At the hearing, police said that there are five suspects in the case and that seven people involved have been questioned.

The detention of former Chief Military Prosecutor

Col. Matan Solomesh, who was arrested with Tomer-Yerushalmi, was also extended until Wednesday. Solomesh is also suspected of fraud, breach of trust, abuse of office, obstruction of iustice, and disclosure of

official information. Tomer-Yerushalmi referred for a psychiatric evaluation after being found on a beach in central Israel, several hours after she had been declared missing on Sunday. Police launched a search when she failed to appear for scheduled meetings. According to a police source, Tomer-Yerushalmi's

car was found abandoned on a beach, and her phone was missing.

Attorney Dori Klagsbald, represents Tomer-Yerushalmi, told the court that there is no evidence she obstructed justice, especially as police had been investigating for a week and had already obtained correspondence from the military prosecutor's office regarding the leak. "Under these circumstances, it is difficult to see how and how to obstruct," he said. The court rejected the claim.

It was 6 P.M. at a military ceremony in central Israel. Dozens of air force officers saluted, several of them se-

nior. But there were no microphones for the eulogies, no cameras commemorating the hugs and tears.

This was a few months ago, but a gag order still blocks the publishing of the name of the officer who was buried that day. He was a senior officer in the reserves, a veteran drone operator. Like many traumatized victims of the war who have taken their own lives, he remains unknown to the public. as are the circumstances that led to the suicide.

"He loved the army and the country very much," says someone who served with him. "The horrors of the war and all the killing were hard for him. It oppressed him. I saw him gradually wilt and lose it."

This source says the senior officer was in charge of drone takeoffs and landings, not the attacks. But he saw everything, the result of ev-

ery takeoff. "I realized that it bothered him, that his participation was hard for him," the source adds. "Most people here might manage to repress it, but for him apparently the wall broke. It didn't happen all at once, but slowly but surely."

In recent months, Haaretz spoke with many

Allegations of bribery, fraud and money laundering

Police raid Histadrut offices, arrest dozens in corruption case

Israel Police raided the offices of the Histadrut labor federation on Monday, arresting dozens of suspects - including senior officials and the union's chairman as part of a corruption investigation.

Two of the suspects, Histadrut chairman Arnon Bar-David and his wife, are accused of bribery, fraud, breach of trust, money laundering and tax offenses The judge partially granted a police request and extended Bar-David's detention until November 10. Along with the chairman of the Histadrut, the police are seeking to extend the detention of seven other people involved.

According to the police, the case involves bribery, fraud and breach of trust in a wide range of public institutions and municipal and government corporate authorities. The case involves a businessman in the insurance sector, allegedly using his connections to appoint individuals chosen by the heads of the Histadrut's workers' committees as

directors in government companies. In return, the committee heads worked to transfer all employees in the companies where they worked to the insurance agency owned by the busi-

nessman. Police also suspect that the businessman leveraged his close relationship of 30 years with Bar-David to influence appointments in various companies. In exchange, Bar-David allegedly received money and other benefits from the businessman.

"[The businessman] benefited from Bar-David's backing," explained a senior police official. "If he manages, for example, to appoint a certain person as chairman of the Histadrut's corporations, he controls the subsequent directorial appointments.

"The suspicion regarding Bar-David is that he entered into a corrupt relationship with others, of giving and receiving various types of benefits," noted the judge ruling the case. "There is reasonable suspicion that supports the allegations in the arrest request - and even more than is required at this stage. There is reasonable basis for fear that releasing the suspect will disrupt the course of the investigation ... and if he is released, there is a fear of coordinating evidence and destroying evidence."

Bar-David's lawyer said in Monday's hearing that his client is cooperating and has nothing to hide. "Most of the offenses are by a public employee," his lawyer added, "why did you arrest his wife? She does not work for the Histadrut. Her arrest

was intended to put pressure See RAID, Page 2
